

## Status of Crab Disaster Relief for 2015-16 Season

- \$25.6 million total funds available June 2019
- \$22.8m direct payments to eligible participants (<5% remaining)</li>
- \$2.6m Phase 2 Mitigation:
  - At least 50% to support enhancing CDPH Food and Drug Laboratory
  - Other 50% will go towards research funding
    - Proposals that aim to better understand domoic acid and how the fishery can adapt to future events
    - Review panel to include industry

## Dungeness Crab Trap Limit Account

- Department costs average ~\$690k FY
- Dept. costs include LRB, LED and Marine, overhead and DCTF Facilitation:
  - Up to \$150k each FY, if available, may be used
  - 2018-2019 Contract over 2FYs was \$150k
  - Current contract covers 2FY also \$150k good until June 30, 2021
- Current statute states excess funds shall be used to reduce trap limit permit (\$1k) or tag fee (\$5/trap)
- Thinking ahead, excess funds could also be used to offset whale entanglement mitigation measures – (i.e. solar loggers)

Revised Pre-Season Testing Protocol for the Tri-State Coastal Dungeness Crab Commercial Fishery

August 2019

- Meeting held May 2019 in Portland, OR
- Discussed and reviewed current quality testing protocols and options to incorporate more flexibility into protocols due to marine life entanglement risk
- Lower meat quality criteria from 25 percent (rounded to the nearest integer) to 24 percent (not rounded) in the region south of Cascade Head, Oregon
  - Expedite a season opener in the northern management area
  - State managers did not adopt this change for the upcoming season pending further discussion with Dungeness Crab Task Force (DCTF)

Revised Pre-Season Testing Protocol for the Tri-State Coastal Dungeness Crab Commercial Fishery

August 2019

- Consider multiple lines within the Tri-State region based on which port areas meet the quality criteria
  - This change could be adopted by Washington and Oregon for the upcoming season;
  - California will not add lines as the current statute specifies that quality delays apply to the entire northern management area
- Allow delays until February 1 after the third round of meat quality testing, but only if the marine life entanglement risk is predicted to be low
  - California can't delay the season beyond January 15 because of existing statute

### New Vessel Size Restrictions: Defined Length Overall & Marine Surveys

- Vessel sizes can be updated via a marine survey that are due by March 31, 2020
- If no survey is submitted, vessel size will default to original permitted vessel length
- Submit surveys along with note identifying that this is to establish the baseline length of the Dungeness crab vessel permit to:

### 2019-2020 Season

- Lost/Abandoned gear
  - Can be pulled by Dcrab permitted vessels July 16- Oct 31
  - \*NEW\* Gear retrieval program in place for post-season 2019-2020
- New buoy tags currently being mailed for 2019-21 biennial period
- NO new gear requirements for upcoming season
  - Limit trailer lengths inside and outside 35 fathoms with no more than 2 trailer buoys
  - BPGs: try to eliminate additional buoys, keep lines taut and maintain gear


