DUNGENESS CRAB TASK FORCE- ELECTION DETAILS

Below is the summary of the final results for the Dungeness crab task force commercial fishermen elections. Within each group, if a nominee did not get a majority of votes based on each voter's first choice, instant run-off voting was used. Successive rounds of voting were tabulated until a single nominee had a majority of the remaining ballots. The numbers provided are for the final round of voting.

The production tier cut-off was 350,051 lbs in five years.

During instant run off voting, if a person only ranked a few nominees and each of those nominees were eliminated in successive rounds of voting, then that person's ballot was removed from the process and the winner was decided based on a majority of remaining votes (i.e., if I ranked Joe Smith #1, but did not indicate a #2 preference *and* if Joe Smith got no other votes and was therefore eliminated in the first round, my ballot would be set aside and would not longer factor in the overall vote count).
