#### Recapping the 2018 FGC Recommendation

- 1. Support addressing peer review recommendations to integrate aspects of both draft management strategies, based on a simulation modeling approach co-developed by DFW and the TNC-led stakeholder team, including engagement with abalone divers and other stakeholders
- 2. Revise FMP goals to allow for a *de minimis* fishery option
- 3. Develop triggers for the *de minimis* fishery option in consultation with stakeholders
- 4. Request that DFW develop a proposed process and timeline which accounts for active public and MRC engagement


• Consensus-based decision-making around outlining the process for management strategy proposal integration

#### Project Team

• Purpose: To review and provide feedback on all scientific analyses conducted by lead modeler, and provide input on the *de minimis* fishery and integrated management strategy design

- Modeling capacity to be provided by Dr. Bill Harford in consultation with affiliates (i.e., peer reviewers and science staff from CDFW and TNC)
- Meetings will be under neutral third-party facilitation (Strategic Earth) to promote coordination and efficiency



#### Project Team

- Anticipated Activities:
  - Consider all recommendations from the final Recreational Red Abalone Peer Review Report;
  - Review all scientific documents provided by lead modeler and affiliates;
  - Provide constructive feedback on science reported by the lead modeler and affiliates;
  - Contribute to the design of de minimis fishery;
  - Propose candidate management strategies based on outcomes of simulation modeling work; and
  - Engage in productive and respectful discussions with all Project Team members and the facilitation team

#### Management Strategy Integration Process


Step #1. Simulation modeling work



May repeat as feedback loop where revised model results presented to Project Team, Project Team provides additional input on model assumptions, and Admin Team reviews feedback from Project Team to inform any necessary tasks for lead modeler and affiliates


#### Management Strategy Integration Process (cont.)
