1. Secretary Chrisman welcomed everyone to the meeting and gave updates on the West Coast Governors' Agreement as well as the Marine Life Protection Act. The Secretary also announced the California Fisheries Challenge 2009 and a new podcast for Thank You Ocean.

The original document was amended to include language recommending that as details of the proposed ban on polystyrene are developed, the impacts on jobs and the economy should be considered.

5. Brian Baird, Assistant Secretary for Ocean and Coastal Policy, presented to the council a summary of work being completed by staff on a statewide climate change adaptation strategy, with a particular focus on the ocean and coastal sector. Mr. Baird introduced three speakers who provided data on the type and extent of climate change impacts that may impact California in the future.
- i. Peter Gleick, the Pacific Institute, discussed a vulnerability assessment of San Francisco Bay and Coastal California to Sea Level Rise and Erosion.
 - ii. Linwood Pendleton, Coastal Oceans Values Center and the University of California Los Angeles, discussed the economic impacts from changes to beaches in Southern California and beach nourishment considerations.
 - iii. Jeffery Dorman, University of California, Berkeley, discussed climate change impacts

on marine species and ecosystems and implications for marine protected areas and fisheries management.

Abe Doherty, project manager, provided an overview of the California's Ocean and Coastal Resources Climate Change Adaptation Strategy outline.

It was moved (Baird) and seconded (Aronberg) to authorize a grant of up to \$1,000,000 to the United States Geological Survey (USGS), the Pacific States Marine Fisheries Commission (PSMFC), and Humboldt State University (HSU) to complete four in-stream flow analyses in three coastal rivers in California to facilitate the Department of Fish and Game’s development of stream flow recommendations for use by the State Water Resources Control Board.

It was moved (Baird) and seconded (Tuck) to approve the adoption of the 2009 Ocean Protection Council/Sea Grant Research Priorities and to disburse up to \$1,000,000 to the California Sea Grant Program and University of Southern California (USC) Sea Grant Program to fund ocean research consistent with these priorities.

14. It was moved (Aronberg) and seconded (Tuck) to approve the adoption of a resolution to protect endangered and threatened sea turtles by opposing a proposed exempted fishing permit (EFP) under consideration by NOAA Fisheries Service for a longline swordfish fishery off California’s coast. The resolution was amended to replace NOAA Fisheries Service with National Marine Fisheries Service (NMFS) and to add a resolved clause to urge NFMS to adopt policies to restrict swordfish and other imports where fishing practices significantly endanger sea turtles or otherwise fail to meet U.S. standards for pelagic longline fishing.
