To the Ocean Protection Council:

I am writing in support of the proposal by Dr. Charles Lester, “Evaluating Adaptation Planning in Coastal California.”

Along with other state agencies, the Coastal Commission is actively working with local governments up and down the California coast on sea level rise adaptation planning. The Commission has adopted Sea Level Rise Policy Guidance and awarded six rounds of grant funding to local governments to perform adaptation planning and update Local Coastal Programs to address sea level rise. This investment of resources, along with support from other local, state, and federal sources, has created an upsurge in local planning for sea level rise resilience and adaptation, and many draft Local Coastal Programs are approaching the local decision-making process as well as consideration before the Coastal Commission. One of the Coastal Commission’s highest priorities, as reflected in its Strategic Plan for 2021-2025, is to advance progress on Local Coastal Program certifications and amendments to address climate change.

This Prop 68 proposal would directly benefit the Coastal Commission and local governments by evaluating the decision-making processes used throughout California’s 76 coastal jurisdictions and making recommendations about how the process might be improved. This research would help accelerate the progress on Local Coastal Programs that is sorely needed to safeguard the State’s communities and coastal resources into the future. Due to this project’s importance, Commission staff plan to participate in an advisory capacity.

As you know, Dr. Lester is well-qualified to research and reflect upon how coastal adaptation planning is working in our state, and both the state and local government interests would benefit from such an evaluation. His proposal also focuses on enhancing the participation of disadvantaged and underrepresented communities in the process, which is an important consideration if we are to find adaptation solutions on our coast that work for all Californians. The Humboldt State University Sea Level Rise Initiative (HSU SLRI) is pleased to offer this letter of support for the proposal by Dr. Charles Lester, **Evaluating Adaptation Planning in Coastal California**.

The HSU [SLRI](#) brings together a group of academic, government, Tribal, planning, and environmental NGO professionals in the Humboldt County region with the mission to “provide regional leadership on sea level rise research and outreach by developing a home for interdisciplinary scholarship related to sea level rise; informing local, regional, and national decision making through collaborative frameworks; and providing a centralized program through which regional sea level rise science and planning efforts can be coordinated.” Members of the SLRI have expertise in planning, social science research methods, GIS techniques, the geosciences, and more. The HSU SLRI focuses predominantly on SLR issues within the Humboldt Bay region, which is facing the fastest rate of relative sea level rise in the entire state of California.

Members of the SLRI have conducted research related to the physical, social, and political conditions related to SLR in Humboldt Bay for many years. We believe that the approach espoused in Dr. Lester’s proposal – to use a statewide approach to evaluate local and state adaptation planning efforts – is an important one that can lead fruitful insights and policy recommendations to improve statewide SLR adaptation planning efforts. The SLRI believes that Dr. Lester and his team will have the appropriate expertise to conduct this research. We are also encouraged to see the emphasis on considering disadvantaged communities in their analysis. Results of this work could have benefits for communities across the state who are grappling with SLR, including those in the Humboldt Bay region.



I am writing to express the City of Del Mar's support for Dr. Charles Lester's application to the California Ocean Protection Council for funding consideration of his proposed **Evaluating Adaptation Planning in Coastal California** through the Proposition 68 Coastal Resilience Grant Program. Dr. Charles's proposed study to "find adaptation solutions on our coast that can work for all Californians" is consistent with the goals of the City of Del Mar to protect the beach, coastal access, critical infrastructure and viability for the future through a rational, sustainable approach.

The City of Del Mar is a strong advocate for increased coastal adaptation resources and is appreciative of the grant assistance being provided by OPC in support of a variety of strategies for resilience and response to sea level rise and climate change. After multiple years of science-based studies, in October 2018, the Del Mar City Council adopted policies, regulations, and long-range plans with a variety of strategies to address projected sea level rise, flooding, and coastal bluff erosion. This included identification of beach nourishment as the City's highest priority, near-term adaptation strategy to address projected local flooding and erosion, which is why the City has also expressed support for SANDAG's application for funding of a regional beach nourishment study in the San Diego region.

We look forward to working with Dr. Lester on his proposed study that will further explore creative opportunities to address climate resilience and consider how the existing regulatory framework for adaptation planning decisions and processes may be improved. It is imperative that decision makers at all levels recognize that beaches are dynamic and context matters. A new mapping effort conducted by the [First Street Foundation](#) shows that in the future, the U.S. will experience drastically more flooding than previously calculated by the Federal Emergency Management Agency (FEMA). The new mapping effort also uncovered that 70% more buildings in the U.S. are vulnerable to flood risk than previously thought, *with most of the flooding impacting low-income neighborhoods.*

Better understanding and engaging underrepresented communities is an imperative step to helping all Californians adapt to the climate crisis and we believe Dr. Lester's effort will be greatly beneficial.
