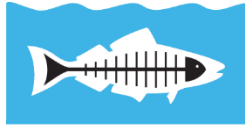

Dear Secretary Crowfoot and Members of the Ocean Protection Council:

We are writing to commend the efforts of the Ocean Protection Council (OPC) to support the Marine Protected Area (MPA) Decadal Review of the network of California State MPAs. California's MPA network serves as a global model both for ocean conservation and for interagency cooperation and collaborative community engagement. Our organizations have been proud to support the MPA network over the past decade with a wide variety of programs from community science to outreach events, to development of curricula and other materials. We believe that review of the effectiveness and achievements of the collective efforts in MPA education and outreach, policy and permitting, enforcement and compliance, and research and monitoring will help ensure the future success of our network and we look forward to continued participation in the process.

As part of the MPA Decadal Review, we encourage OPC and its partners the California Department of Fish and Wildlife and California Fish and Game Commission to prioritize efforts to share information about the state's partnership-based approach to MPA management as well as seek input on how the state can better meet the goals of the Marine Life Protection Act over time. We specifically encourage support for synthesis of scientific and other information into concise summaries and easily understandable illustrations and graphics and to disseminate this information through channels that will reach a broad range of interested parties. We also encourage the state to post relevant information on state websites in a timely manner and provide content that can easily be shared by partner organizations such as our own.

With respect to the MPA projects before you at your September meeting, we recommend fully funding the statewide MPA signage project, which is designed to first evaluate needs and success of various messaging to specific audiences to ensure funding is allocated wisely. The project will assess statewide signage needs and evaluate existing signage effectiveness; develop and finalize a mobile application for tracking and updating access points and signage at all MPAs. This work will prepare us to fill future signage gaps across the state effectively.

Finally, we also strongly recommend funding the California Collaborative Fisheries research Program (CCFRP) for the full amount. CCFRP is an innovative collaborative research project that provides both a valuable opportunity for fishermen and scientists to work together and generates an important dataset to inform MPA managers as well as state and federal fisheries management. The program also has an important outreach component: CCFRP recently volunteered staff time to co-create a video series targeting anglers to discuss topics such as spillover and catch and release. Feedback from the angling community regarding the videos has been overwhelmingly positive.

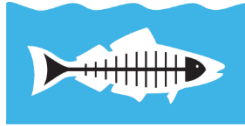

We specifically encourage support for synthesis of scientific and other information into concise summaries and easily understandable illustrations and graphics and to disseminate this information through channels that will reach a broad range of interested parties. We also encourage the state to post relevant information on state websites in a timely manner and provide content that can easily be shared by partner organizations such as our own.

With respect to the MPA projects before you at your September meeting, we recommend fully funding the statewide MPA signage project, which is designed to first evaluate needs and success of various messaging to specific audiences to ensure funding is allocated wisely. The project will assess statewide signage needs and evaluate existing signage effectiveness; develop and finalize a mobile application for tracking and updating access points and signage at all MPAs. This work will prepare us to fill future signage gaps across the state effectively.

Finally, we also strongly recommend funding the California Collaborative Fisheries research Program (CCFRP) for the full amount. CCFRP is an innovative collaborative research project that provides both a valuable opportunity for fishermen and scientists to work together and generates an important dataset to inform MPA managers as well as state and federal fisheries management. The program also has an important outreach component: CCFRP recently volunteered staff time to co-create a video series targeting anglers to discuss topics such as spillover and catch and release. Feedback from the angling community regarding the videos has been overwhelmingly positive.
