





I hope what I just said will make you consider helping our school with a future project. It will really encourage kids to learn about the environment, nature, and improve our overall health



The District will not be providing any funding for the construction of the Project, and any front-funding required to cover District costs will not be allocated without prior approval of the District's Board of Directors ("Board"). At the expiration of the maintenance obligations of TreePeople, the District will accept responsibility for the continuing maintenance of the Project in accordance with the District's annual maintenance and operations budget, and only as specified in a written agreement executed by all applicable parties.

The District strongly supports the proposed Project and the efforts of TreePeople to add additional green space at Wilmington.
