Dungeness Crab Fishery Management Authority Overview



Commercial fishery legislatively regulated

 Fish and Game Commission has limited authority over the commercial fishery and full authority over recreational fishery regulations





Commercial Regulations



- DFW is Management Agency
- Basic Management Scheme (3-S):
 - 1. Size minimum size 6.25 inches
 - 2. Sex keep males only
 - 3. Seasons -

Northern CA (Pt Arena north): Dec 1 thru July 15 Central CA (District 10): Nov 15 thru June 30

- Limited Entry (1995)
- Trap Limits (as of 2013-14)



Additional Requirements



- Commercial Fishing License and Dungeness Crab Vessel Permit
- Traps must be owner ID'd and buoys must have Buoy Tag
- Prior to each season an affidavit must be filed describing the tag number, date and location where all lost buoy tags were last observed
- Landing Receipt is primary source of fishery catch and effort information; logbooks not required



Dungeness Crab Task Force (DCTF)



- Dungeness Crab Task Force required by statute (FGC Sec 8276.4)
- Advisory group makes fishery recommendations

 e.g. Evaluate Trap Limit Program, and other
 management issues
- 2015 & 2017 Reports to Legislature and Management Agencies
- Forum to discuss coastwide coordination of other crab management issues
- No funding after this current session




Tri-State Dungeness Crab Committee

- WDFW, ODFW and CDFW with PSMFC coordination
- Interstate cooperation on pre-season condition testing and season openings north of Pt Arena
- Forum for discussing other crab issues





Landings in the Commercial Fishery by Region (50 years)








Potential Traps Estimated From Vessels by Month and Region: 2013-14 Season (454 total vessels)






Number of Dungeness crab Vessels per Month by Area (North, N Central, & S Central): Nov 2010 - Mar 2015






Observed/Documented Whale Entanglement Events by CA Fishery: 2000-2014
