Amendment 1 On page 5, line 21, delete "2014" and insert: "2015"

Amendment 2 On page 5, line 26, before "Dungeness crab permit" insert: "California

Amendment 3 On page 5, line 26, before "landings" insert: "California"

Amendment 4 On page 5, line 28, after "inclusive" insert: "as reported in California landings receipts"

Amendment 5 On page 5, line 30, delete "who landed less than" and insert: "whose California landings were less than"

Amendment 6 On page 5, line 31, after "inclusive" insert: "as reported in California landings receipts"

## Amendment 20

On page 6, delete lines 23 through 25, and insert: "The remaining permits with the next highest landings to those in subparagraph (E) that do not fall under the definition in Section 8276.4 (h) (1) or (2), shall receive a maximum allocation of 250 trap tags."

Amendment 21

On page 6, delete lines 26 and 27 and insert: "All permits defined in Section 8776.4 (h) (1) or (2) shall receive a maximum allocation of 175 trap tags."

## Amendment 22

On page 6, starting on line 36, delete through line 3 on page 7 and insert: "(3) Individuals may appeal their pot allocation(s) to the Director on a permit by permit basis for the purposes of revising upward or downward any trap tag allocation based on evidence that a permit's California landings during the period between November 15, 2003 and July 15, 2008, were reduced as a result of unusual circumstances and that these circumstances constitute an unfair hardship, taking into account the overall California landings history as indicated by landing receipts associated with the permit. The Director shall initiate the appeal process within twelve months of the appeal request. The appeal shall be heard and decided by a judge, whose decision shall constitute the final administrative decision of the Director. Any individual requesting and appeal shall pay all expenses associated with the appeal process.

## Amendment 23

On page 7, delete lines 4 and 5, and insert: "(4) The director shall not institute a pilot program for Dungeness trap tags, for a period longer than three years unless a longer period is authorized by a two thirds vote of the non ex officio members of the Dungeness crab task force."

## Amendment 24

On page 7, line 7, delete "shall not" and insert: "is not required"

Amendment 25

On page 7, line 9, after "fishery" insert: "Penalties and fines for noncompliance shall be promulgated by the Director. All crab traps being fished must contain a trap tag that shall be fastened to the first buoy."
